- This application will be considered at the absolute discretion of the Council, whose decision is final.
- The Registrar may request an inspection of the pony by an appointed inspector, DNA testing , or a veterinary assessment/licence for stallions before registration can be confirmed.

Note: Any inspection, testing, or assessment requested by the Society will be carried out at the owner's expense.

- Colts 2 years & above/Stallions - acceptance under Rule 13 will be provisional only, final registration onto the Supplementary Register will be granted only upon successful completion of obtaining a stallion license.
- The Council may refuse or cancel registration if it deems acceptance detrimental to the objectives of the Society.
- Any Council member or individual connected to the pony will not take part in the decision-making process.
- Submission of this application does not guarantee registration.
